VII. BUSINESS SESSION

1. Certificate of Recognition – (Dixie Curley)

2. Proclamation – (Law Enforcement Appreciation Week – May 13th – May 19th) **APPROVED**: Motion – Smolar; Second – Sprayberry.

3. Amend Personnel Policy Regarding (Annual Leave Accrual Rate for City Employees) Councilmember Smolar presented a request to the Mayor and Council regarding a change in the personnel policy regarding the accrual of annual leave for employees and removing the current cap on the accrual of sick leave. Councilmember Smolar advised that this change would make the annual

leave accrual rate more consistent with other municipalities. The proposed annual leave accrual rate is as follows:

PROPOSED ANNUAL LEAVE ACCRUAL RATE	
Years of Service	Annual Leave Accrual
1 – 10 years	80 hours annually
10 years or more	120 hours annually

- 4. Consideration of Approval Police Chiefs Conference Councilmember Sprayberry presented a request for Chief Eddie Thompson to attend the annual Police Chiefs Conference which will be held July 22, 2018 July 25, 2018. The cost for the conference will be approximately **\$1,015.50**, which includes the conference cost and hotel expenses. **APPROVED**: Motion Sprayberry; Second Smolar. VOTE: 4-0
- 5. Consideration of Approval UGA -CVIOG Municipal Clerk's Conference Councilmember Smolar presented a request for Sherry Bilbo and Brittany Reichert to attend the University of Georgia (Carl Vinson Institute of Government) Municipal Clerk's Conference which will be held September 9, 2018 September 11, 2018. Councilmember Smolar advised that he would be receiving his Clerk's Certification diploma during the conference and would be paying his own hotel expenses. The purpose for attendance at the conference for Brittany and Sherry is for mandated training for Brittany and meeting continuing education requirements for Sherry. The total cost for the conference and hotel expenses for both individuals to attend will be \$1,158.00.

- 6. Discussion of Post July 4th Event The Mayor and Council discussed the upcoming Post July 4th Block Party which will be held on Saturday, July 7th at the Recreation Department. Topics discussed included the following:
- 1. Fireworks Councilmember Williford stated that the approximate cost for fireworks at the event will be \$3,400. Councilmember Williford advised that he has had two local businesses agree to contribute \$1,000 each toward the fireworks.
- 2 Live-Entertainment Councilmember Smolar advised that Whooping Creek Jam Band has agreed to play at the event at a price of \$400.00
- 7. Approval of Cardiac Science Agreement in the amount of \$1,200.00 **APPROVED**: Motion Williford; Second Sprayberry. VOTE: 4-0
- 8. Approval of Resolution 03-2018 Authorizes the Mayor to enter into an Agreement between Georgia Municipal Association and the City of Whitesburg for Telecommunications & Right of Way Management

VIII. CITIZEN COMMENTS

Mr. Bucky Bowen, Chairman of the Planning Commission, spoke to the Mayor and Council regarding a building permit for Sammy Duke for a 20 x 12 ft. storage building. Mr. Bowen stated that property is zoned commercial. Mr. Duke advised that the property is approximately one acre and he would like to place a storage building on the property to store his tools. Mr. Duke stated that there was a septic tank on the property. Councilmember Gamble inquired to Mr. Duke as to whether he planned to obtain plumbing, electrical, and HVAC permits. Mr. Duke stated that for now the building would be used for storage purposes only.

Mr. Darryl Hessel stated that he was on the sub-committee for bus transportation for the county. Mr. Hessel stated that the County will eventually have six (6) buses. Mr. Hessel stated that the cost for the bus transportation will be \$3.00 to go anywhere in the County. Mr. Hessel also advised that a meeting will be held soon to introduce the bus system. Mr. Hessel also advised that the Old City Hall is currently being renovated and will open June 2, 2018.
